When does the liability get charged? You will be charged at the counter immediately for the reported damage or within 28 days of return of the vehicle for unreported damage.

LDW (Loss Damage Waiver): Relieves you from financial responsibility for damage to the rental vehicle (provided the loss or damage does not result from using the vehicle in violation of the rental terms).

Your responsibility for damage to the vehicle is set out at the Damage and Theft section of the Rental Terms. This policy covers how we assess and charge for damage and how we deal with any ...

For damages charged together with the rental charges at time of return, no further contact will be made. For damages involving third parties we will gather all required information (vehicle incident report, ...
