Finally, a household with more than 300 units of average monthly electricity consumption would need a rooftop solar plant capacity of more than 3 kilowatts and the applicable subsidy will be Rs 78,000. Households can apply for the subsidy through the National Portal, where they can also select a suitable vendor for installing rooftop solar.
