Can a provider sell a photovoltaic system to a customer?

WHEREAS, Provider has offered, at his sole cost and expense, to install, maintain, own, replace, repair, and operate a photovoltaic system at one or more of the Property (ies) and to sell Solar Services (as hereafter defined) produced by the solar photovoltaic system to Customer as provided in and subject to the provisions of this Agreement.

What percentage of solar services should a customer purchase?

Customer agrees to purchase one hundred percent(100%) of the Solar Services produced from and after the Commercial Operation Date until the end of the Term. Customer shall purchase all such Solar Services at the kWh Rate whether or not the Customer can use all such Solar Services.

Do you need a solar power agreement?

These agreements can be related to a solar power lease,PPA,or outright buying of the system. Whenever developing alternate forms of power,it's good to have an agreement with your Provider. This ensures everyone is clear on their roles and responsibilities.

Can solar production be estimated?

Solar production can only ever be estimated. So make sure that any assumptions given by the Provider are clear,reasonable,and make sense. If you don't understand any of the estimates provided,make sure to ask your Provider before signing a contract.
